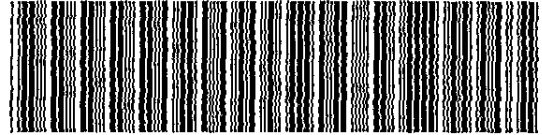

The undersigned incorporator(s), for the purpose of forming an Corporation under the Florida Business Corporation Act, hereby Adopt(s), the following Articles of Incorporation.
