Article 1

Corporate Name

The name of this corporation shall be "DM MEDIA VENTURES, INC."

Article 2

Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 1000 Lowery Street, #5F, Delray Beach, Florida 33483.

Article 3

Nature of Corporate Business

The general nature of the business to be transacted by this Corporation shall be to engage in business for profit and it is organized for the following general purposes:
