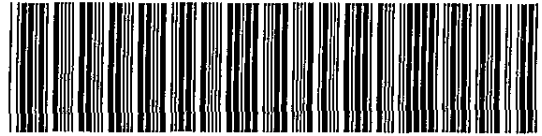

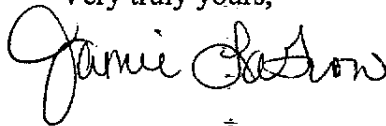

ARTICLES OF INCORPORATION
OF
BILL KLOSTERMANN ELECTRICAL, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is BILL KLOSTERMANN ELECTRICAL, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 2549 W. Ozark Road, Avon Park, Florida 33825

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

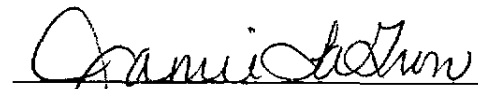

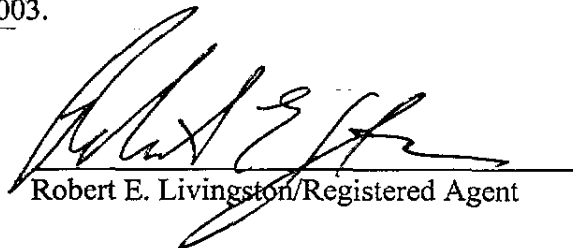

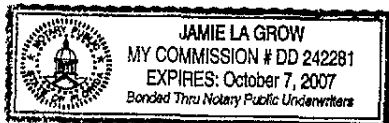
