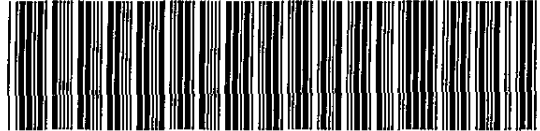

# ARTICLES OF INCORPORATION FOR COASTAL EMPIRE, P.A.

## Article I Corporate Name

The name of the corporation is COASTAL EMPIRE, P.A.

## Article II Principal Office

The principal place of business and mailing address of this corporation are 615 Mickens Lane, Key West, Florida, 33040.

## Article III Purpose

This corporation is organized for the following purposes:

- a. To engage in the practice of medicine as a professional corporation and to own and operate a medical clinic for the purposes of providing medical care and treatment
- b. To own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional medical services.
- c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional medical services in the State of Florida.

## Article IV Capital Stock

The maximum number of shares this corporation is authorized to issue is one thousand (1000) shares, all of which shall be common shares. The corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than thirty-five (35) natural persons, or the estate of such natural persons. Additionally, no stock shall be issued or transferred to a nonresident alien. All common
