ARTICLE 1 - NAME

The name of the Corporation shall be BAY ADVANTAGE, INC., (hereinafter, "Corporation").

ARTICLE 2 - PURPOSE OF CORPORATION

The Corporation shall be formed for the primary purpose of providing home inspection services utilizing the Pillar to Post® system.

ARTICLE 7 - TERM OF EXISTENCE

This Corporation shall have a perpetual existence.

ARTICLE 8 - BYLAWS
