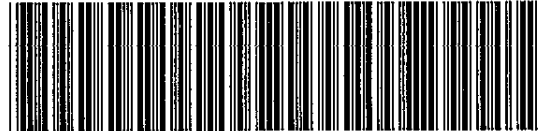

7. **INITIAL BOARD OF DIRECTORS**, this corporation shall have 1 director initially. The number of directors may be either increased or decreased from time






