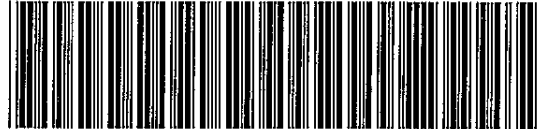

This corporation is authorized to issue One Hundred shares of One Dollar ( \$1.00 ) par value common stock.

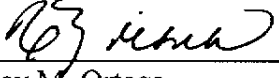
