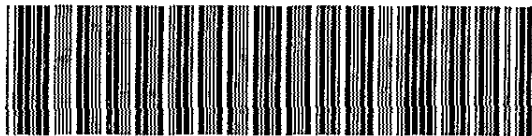

The introductory paragraph of the Document stated that the signatory was licensed to practice law in the State of Florida.



Correction


The introductory paragraph is corrected and amended to read as follows:
