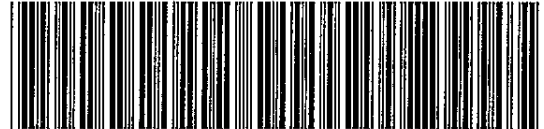

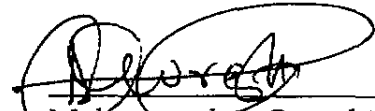

## **ARTICLE X – AMENDMENT**

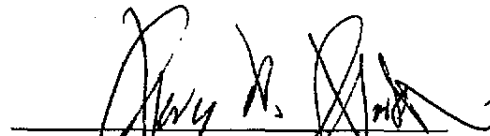
