ARTICLES OF INCORPORATION

<u>OF</u>

GUNTER CONSTRUCTION, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article I. Name.

The name of the Corporation is: GUNTER CONSTRUCTION, INC.

Article II. Duration.

The duration of the Corporation is perpetual.
