Dear Sirs:

I'm sending this letter with the Corporate Filing Report to respectfully request a waiver of the \$400. penalty for late filing. As you can see from the enclosed envelope, which is postmarked April 29, 2004, I did send the form and money order before the deadline of May 1, 2004. I mistakenly put the wrong address in the window and it came back to me. We were out of town and I just picked up the mail and discovered the error.

Your envelope design for this form can very easily cause mistakes in sending it. Why can't you just send addressed envelopes instead of the window envelope, or put the window in a different part of the envelope so that only the correct address will be readable through the window in the envelope? Next year I will not be using your envelope but will address my own so I'll be sure not to make such an easy error. I'm sure that I'm not the only one that made this mistake.

Any consideration you can give me regarding the penalty would be greatly appreciated, as we have not begun business under the corporation yet, because we could only get a Federal License after the corporate license.
