In October 2004 the office location and my principle residence changed, and we also experienced numerous changes in office staff. I do not recall ever receiving the paperwork for filing of the Annual Report at my current address. I have recently become aware of the fact that the Corporation status is Inactive and would like to correct this problem.

Being Incorporated is new to me, therefore I was unaware of the proper procedures for filing address changes and annual reports. Please waive the reinstatement fees based on this confusion.
