ARTICLES OF INCORPORATION

OF

CRONIN INDUSTRIES, INC.



ARTICLE I - NAME

The name of this corporation is CRONIN INDUSTRIES, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually.
