ARTICLES OF INCORPORATION

OF

MARK VERY - CARPENTER, INC.



The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME AND PRINCIPAL OFFICE

The name of this corporation is Mark Very - Carpenter, Inc., and its principal office is located at 149 Yucatan Drive, Pensacola, Florida 32506, and its mailing address is 149 Yucatan Drive, Pensacola, Florida 32506.

ARTICLE II DURATION

This corporation shall exist perpetually.
