



ARTICLE I
NAME

The name of this Corporation is: *Shaun Cleveland, Inc.*

ARTICLE II
DURATION

This Corporation shall exist perpetually.

ARTICLE III
PURPOSE

This Corporation is organized for the purpose of operating as an aluminum soffit, gutter & siding company, and to operate in any lawful business.

ARTICLE IV
CAPITAL STOCK




