

ARTICLES OF INCORPORATION

OF

MARKETING USA, INC.

FIRST: I, Kees Smeehuyzen, whose post office address is 523 Canoe Point, Delray Beach, Florida 33444, being at least 18 years of age, acting as incorporation under and by virtue of the Florida Business Corporation Act.

SECOND: The name of the corporation is MARKETING USA, INC. (the "Corporation").

THIRD: The purposes for which the Corporation is formed are (1) to import, export and market goods and services and (2) to engage in any other lawful business. The Corporation also shall have all the general powers granted by law to Florida corporations and all other powers not inconsistent with law that are appropriate to promote and attain its purposes.

FOURTH: The post office address of the principal office of the Corporation is 523 Canoe Point, Delray Beach, Florida 33444, with mailing address of P.O. Box 546, Delray Beach, Florida 33447. The name of the registered agent of the Corporation is Kees Smeehuyzen who is an individual resident of the State of Florida and the registered office of the Corporation is 523 Cance Point, Delray Beach, Florida 33444.

FIFTH: The total number of shares of capital stock that the Corporation has the authority to issue is 100,000, all of one class called Common Stock, par value \$1.00 per share. The aggregate par value of all of the shares of the Common Stock is \$100,000.

SIXTH: The Corporation shall initially have one director until changed as provided by the bylaws of the Corporation. The name and address of the individual who will serve as directors until the first meeting are as follows:

SEVENTH: The Corporation shall indemnify, to the fullest extent permitted by Florida law, as applicable from time to time, all persons who at any time were or are directors or officers of the Corporation for any threatened, pending or completed action, suit or proceeding (whether civil, criminal, administrative or investigative) relating to any action alleged to have been taken or omitted in such capacity as a director or an officer. The Corporation shall pay or reimburse all reasonable expenses incurred by a present or former director or officer of the Corporation in connection with any threatened, pending or completed action, suit or proceeding (whether civil, criminal, administrative or investigative) in which the present or former director or officer is a party, in advance of the final disposition of the proceeding, to the fullest extent permitted by, and in

accordance with the applicable requirements of, Florida law, as applicable from time to time. The Corporation may indemnify any other persons permitted but not required to be indemnified by Florida law, as applicable from time to time, if and to the extent indemnification is authorized and determined to be appropriate in each case in accordance with applicable law by the board of directors, the shareholders or special legal counsel appointed by the board of directors. The Corporation shall not be required to purchase or maintain insurance on behalf of any present or former directors or officers or other persons required or permitted to be indemnified. No amendment of the charter of the Corporation or repeal of any of its provisions shall limit or eliminate any of the benefits provided to directors and officers under this Article in respect of any act or omission that occurred prior to such amendment or repeal.

EIGHTH: The duration of the Corporation shall be perpetual.
