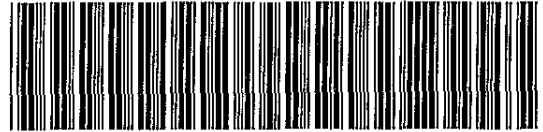

## ARTICLE SIX

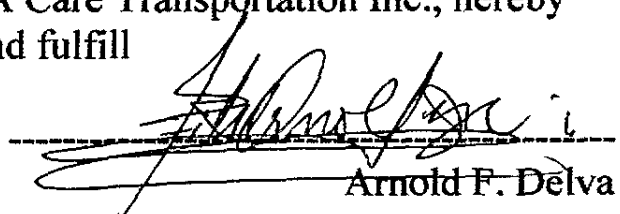
