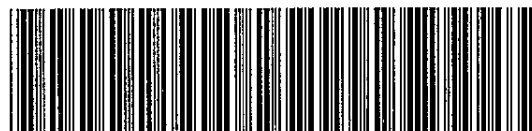

***ARTICLE I. NAME***
