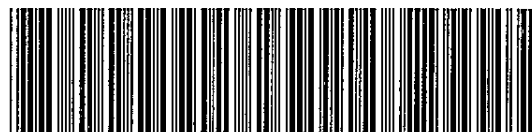

**ARTICLES OF INCORPORATION  
OF  
PIKE'S CUSTOM LAWNS, INC.**

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby set forth their intention to form a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation is PIKE'S CUSTOM LAWNS, INC.

**ARTICLE II**

This corporation shall begin its existence on January 1, 2004, and exist perpetually.

**ARTICLE III**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.


