**ARTICLES OF INCORPORATION
OF
VINTAGE TOPCOATS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **VINTAGE TOPCOATS, INC.**

ARTICLE II

The existence of the Corporation shall begin on the date on which these articles are filed with the Secretary of State.

ARTICLE III

The street address of the principal office of the Corporation is 5139 Sweat Road, Green Cove Springs, Florida 32043.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000, par value One Dollar (\$1.00) per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
