ARTICLE 1 - NAME OF CORPORATION

The name of the corporation is PAINTING BY TIM CATE, INC.

ARTICLE II - NATURE OF BUSINESS

The corporation is authorized to conduct any lawful business in the State of Florida which is not prohibited by law, rule or regulation.
