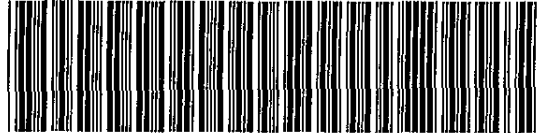

STATE OF FLORIDA.

ARTICLE I

NAME

The name of this corporation is **LAVIGNE MAINTENANCE, INC.**

ARTICLE II

PURPOSE

This corporation may engage in any activity or business permitted under the laws of the United  
States and of the State of Florida.

ARTICLE III

CAPITAL STOCK
