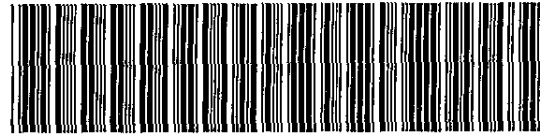

The undersigned subscriber, natural person competent to contract, for the purpose of forming a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

**ARTICLE I
NAME**

The name of the proposed corporation is: COASTAL TILE OF FLAGLER, INC.

**ARTICLE II
PRINCIPAL OFFICE**

The principal place of business address of the corporation is 2609 Lakeshore Boulevard, Flagler Beach, Florida 32136 and the mailing address is P. O. Box 1442, Flagler Beach, FL 32136.

**ARTICLE III
PURPOSE**

The general nature of the business to be transacted by this corporation shall be any activities or business permitted under the laws of the United States and of the State of Florida.

**ARTICLE IV
CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1000) shares of common stock, no par value.

**ARTICLE V
AMENDMENTS**

These Articles of Incorporation may be amended in the manner provided by law.

Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon, unless all the Directors and all the stockholders sign a written statement manifesting their intention that a certain amendment of these Articles be made.

ARTICLE VI TERM OF EXISTENCE

This corporation is to exist perpetually.

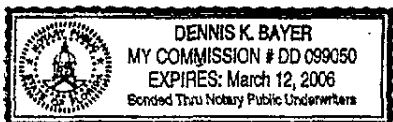
