

The undersigned Incorporator hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I. CORPORATE NAME

#### ARTICLE III. CAPITAL STOCK

The aggregate number of shares of stock that this

Corporation is authorized to issue and have outstanding at any
