### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

## SEVEN/SCHATZ I, INC. | corrected as SEVEN-SCHATZ I, INC.| A Florida corporation

WHEREAS, the Articles of Incorporation electronically filed with the Secretary of State on December 15, 2003, as received back by the corporation, inadvertently stated the name of the corporation as SEVEN /SCHATZ I INC.; when they should have stated SEVEN-SCHATZ I, INC.;

WHEREAS, the Shareholder and the Board of Directors of the corporation desire to correct this provision and change the name of the corporation with the Secretary of State to read SEVEN-SCHATZ I, INC.;

1. ARTICLE I of the ARTICLES OF INCORPORATION of SEVEN-SCHATZ I, INC. [corrected as SEVEN-SCHATZ I, INC]., is hereby deleted in its entirety and the following is substituted in place thereof:
