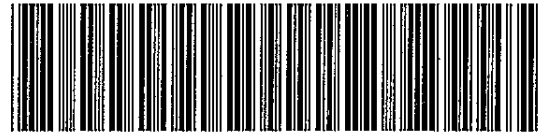





The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

STAN'S TREE SERVICE OF DAYTONA, INC.

The principal place of business of this corporation shall be 1838 Nova Road, Daytona Beach, Florida 32117, and the mailing address shall be 1838 Nova Road, Daytona Beach, Florida 32117.

ARTICLE II. NATURE OF BUSINESS




