Pursuant to the provisions of Section 607.1401 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Dissolution:

Article I - Name of Corporation

The name of the corporation is **PVC WORLD, INC.** (hereinafter referred to as the "Corporation").

Article II - Filing Date of Articles of Incorporation

The Articles of Incorporation of the Corporation were filed with the Secretary of State of the State of Florida on December 9, 2003.

Article III - Failure to Issue Share

Article V - Approval of Dissolution
