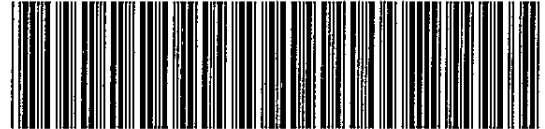


ARTICLE VII. AMENDMENT



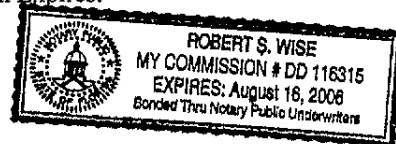


