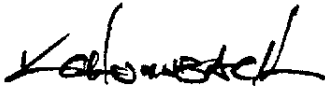

The undersigned Incorporator hereby adopts the following Articles of Incorporation ("Articles") for the purpose of forming a profit corporation under the Florida Business Corporation Act.

**ARTICLE I
CORPORATE NAME AND PRINCIPAL OFFICE**

The name of the Corporation shall be **MRKB One, Inc.**, and the address of the principal office of the Corporation, which is also its mailing address, is 2960 Immokalee Road, Building A, Naples, Florida 34110.

**ARTICLE II
PURPOSE**

The purpose for which the Corporation is formed is to engage in any activity within the purposes for which corporations may be formed under the Florida Business Corporation Act.

**ARTICLE III

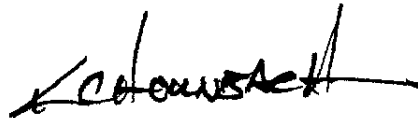
