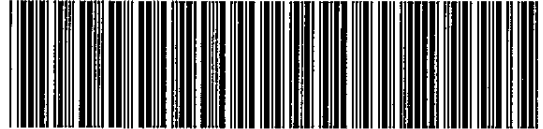

**Article I
Corporate Name**

The name of the corporation is Ann's Accounting Service, Inc.

**Article II
Principal Office**

**Article III
Purpose**

The purpose for which this corporation is organized is to engage in accounting services, bookkeeping, and consulting, as well as to carry on any and all incidental business.
