The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I. NAME. The name of the corporation is, MARGARET M. CROKE ,INC., located at 1409 Belmont Pl., Boynton Beach, FL 33436.
