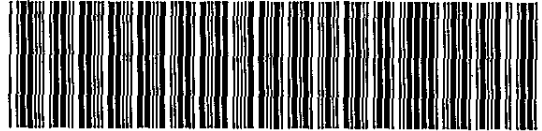

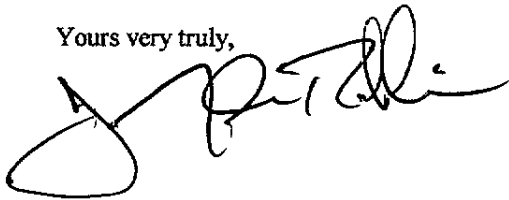

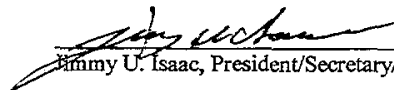
ARTICLE IX-IMDEMNIFICATION

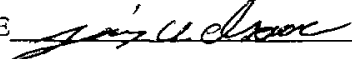

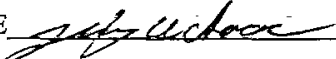
