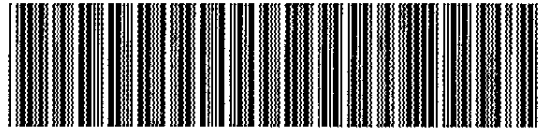



The name of this corporation is: **GRACE DEVELOPMENT COMPANY OF SANTA ROSA.**

ARTICLE II

The term of existence of the corporation is perpetual.

ARTICLE III

The purpose of this corporation is to buy and sell residential and commercial real estate and any and all other lawful business.

ARTICLE IV - CAPITAL STOCK


