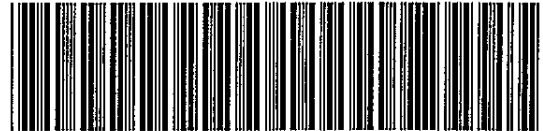

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation is PAUL'S CONCRETE PUMPING, INC.

ARTICLE II. NATURE OF BUSINESS




