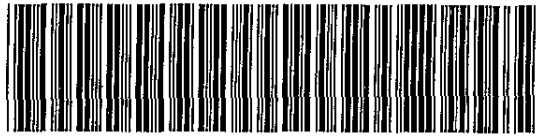

The undersigned, being of the age of eighteen years or more, does hereby make and acknowledge the Articles of Incorporation for the purpose of forming a business corporation under and by virtue of the laws of the State of Florida in accordance with the Florida General Corporation Act.

**ARTICLE I**

The name of the corporation is BILLY E. HYERS TREE SERVICE, INC.

**ARTICLE II**

The principal place of business and mailing address of the corporation is 2081 Chaffee Road South Lot #100, Jacksonville, Duval County, Florida 32221.

**ARTICLE III**

The purpose for which the corporation is organized is to engage in any lawful act or activity for which corporations may be organized under the Florida General Corporation Act.

**ARTICLE IV**

The corporation shall have authority to issue seven thousand five hundred (7,500) shares of common stock having a par value of One Dollar (\$1.00) per share.

## ARTICLE V

The address of the initial registered office of the corporation in the State of Florida is 2081 Chaffee Road South Lot #100, Jacksonville, Duval County, Florida 32221; and the name of its initial registered agent at such address is Billy E. Hyers, II. The principal office of the corporation and the office of the Registered Agent are both located at 2081 Chaffee Road South Lot #100, Jacksonville, Duval County, Florida 32221.

## ARTICLE VI

The number of Directors constituting the initial Board of Directors shall be two (2). The number of Directors may be increased or decreased from time to time in accordance with the By-Laws adopted by its shareholders, but the number of Directors shall never be less than one (1). 


