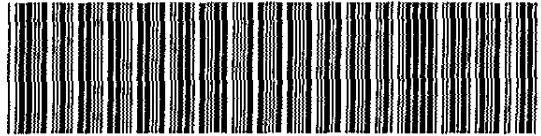

ARTICLE I - NAME

The name of this corporation is: Commercial Residential Contracting, Incorporated.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

The nature of the business to be transacted by this corporation and the purpose hereof is to provide general building contractor services to the general public and to do all things in connection therewith that is customarily done by general building contractors. The corporation may own real or personal property necessary for the rendering of general building contractors' services. The corporation shall not engage in any business other than that customarily performed by general building contractors, licensed by the State of Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares of capital stock which this corporation shall be authorized to issue and have outstanding at any one time is 100 shares of common stock having a par value of \$1.00 per share.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

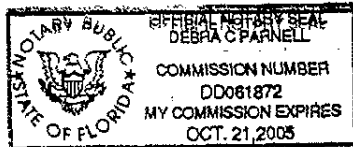
