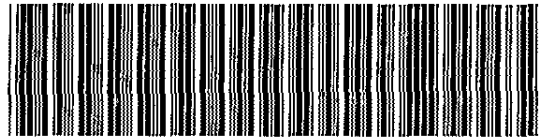

ARTICLE I- NAME
