**ARTICLE III**

***DURATION:***

The Corporation shall have perpetual existence.

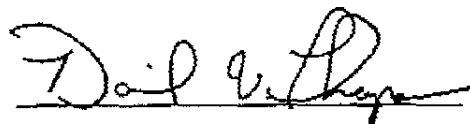

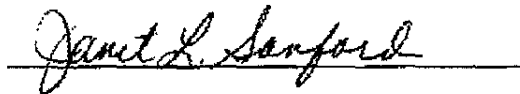

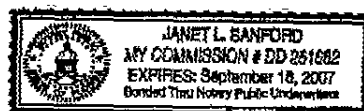
