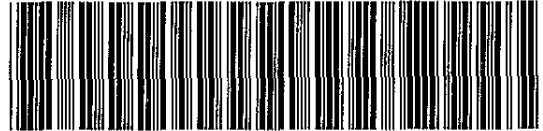

ARTICLE I - NAME

The name of this Corporation is Mr. Wahoo Enterprises, Inc.

ARTICLE II - NATURE OF BUSINESS


