**ARTICLES OF INCORPORATION  
OF  
SMH SPACE SERVICES, INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME AND ADDRESS**

Section 1.1 Name. The name of the corporation is SMH Space Services, Inc.

Section 1.2 Address of Principal Office. The address of the principal office of the corporation is 314 Sophia Terrace, St. Augustine, Florida 32095.

**DURATION**

Section 2.1 Duration. This corporation shall exist perpetually. INDEMNIFICATION




