ARTICLES OF INCORPORATION

OF

NEW IMAGE LAWN CARE OF BREVARD, INC.

ARTICLE I - NAME

The name of the corporation is New Image Lawn Care of Brevard, Inc., at 2150 Woodbury Road, Melbourne, FL 32935 (Principal Office of Registered Agent).

ARTICLE II - DURATION
