I, the undersigned, being of sound mind and legal age, do hereby agree for myself and my associates and assigns to become a corporation for profit under the laws of the State of Florida, providing for the formation, liability, rights, privileges, benefits and obligations conferred and imposed by such laws on corporations organized pursuant to the provisions thereof, and do hereby make, subscribe, acknowledge and agree to and file these Articles of Incorporation as follows:

ARTICLE I. NAME

ARTICLE II. EFFECTIVE DATE AND DURATION

This corporation shall be effective on January 1, 2004, and shall have perpetual existence.

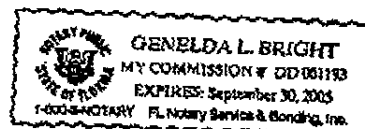
