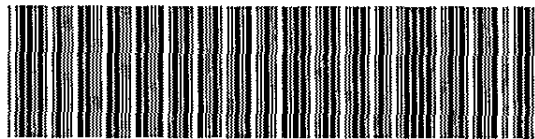

2.) The document number of this Corporation is **P03000152854**.

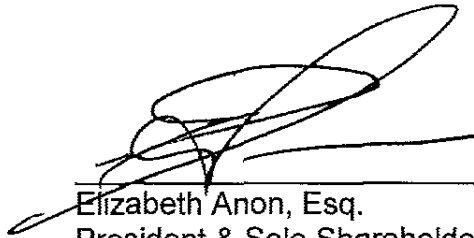
3.) The Shareholder and Director of the Corporation authorized the dissolution on **March 26, 2007**.
