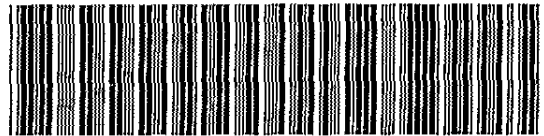

The undersigned incorporator makes and files with the Department of State of the State of Florida these Articles of Incorporation for the purpose of forming a corporation for profit under the laws of the State of Florida.

ARTICLE I

Name

The name of this corporation is: CHEERS HOME DELIVERY, INC.

ARTICLE II

Principal Office/Mailing Address

The principal office and mailing address of the corporation shall be 4063 E. Irlo Bronson Highway, St. Cloud, Florida 34771, until such time as the corporation notifies the Department of State of the State of Florida of any change.

ARTICLE III

Term of Existence

This corporation shall commence as of the date of the filing of these Articles with the Secretary of State and shall have perpetual existence.

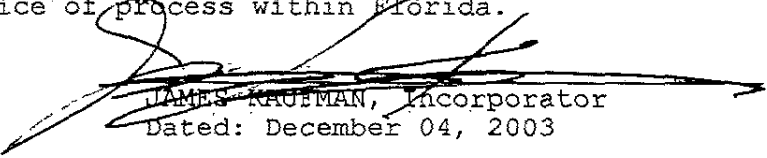

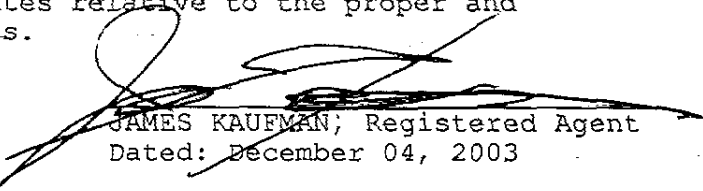
