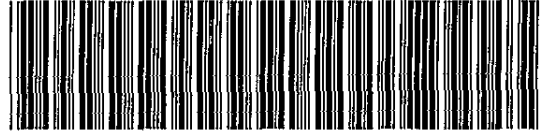

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is HUGH BABCOCK, INC.

ARTICLE II
NATURE OF BUSINESS

The corporation is organized for the purpose of transacting any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III
PRINCIPAL OFFICE

The principal office and original mailing address of the corporation is 1432 Lawrence Place, Jacksonville, Florida 32211.

ARTICLE IV
CAPITAL STOCK

A. **Authorized Capital.** This corporation is authorized to issue one thousand (1,000) shares of the par value of One Dollar (\$1.00) each, which shall be designated "Common Shares."
