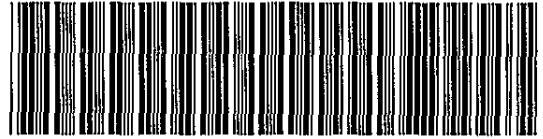

ARTICLE ONE

The name of the corporation is FALLIN TILE & MARBLE, INC.
