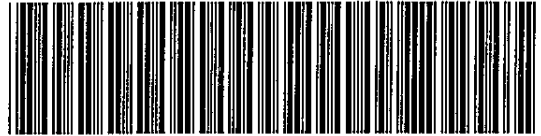

The name of this corporation is PURON CIGARS, INC.


ARTICLE VIII - BEGINNING OF CORPORATE EXISTENCE




