ARTICLES OF INCORPORATION

OF

POWELL ENTERPRISES OF POLK COUNTY, INC



ARTICLE ONE NAME

The name of the corporation is POWELL ENTERPRISES OF POLK COUNTY, INC.

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual from the date of incorporation.

ARTICLE THREE PURPOSES

The general purposes for which the corporation organized are:

- 1. To perform professional home inspections and organize and facilitate fishing excursions, and to own or lease all equipment and real or personal property necessary for these purposes.
- 2. To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR

CAPITALIZATION

The aggregate number of shares which the corporation is authorized to issue is one hundred. Such shares shall be of a single class, and shall be without par value.
