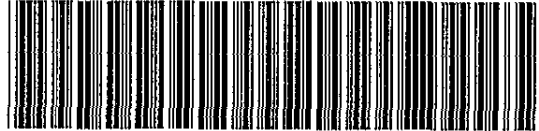

ARTICLES OF INCORPORATION
OF

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provision of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation for profit, pursuant to Chapter 607, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of this corporation shall be PAUL GRONQUIST, INC.

ARTICLE II

Principal Office

The principal place of business and mailing address of this corporation is hereby designated to be 6325 Salado Road, St. Augustine, Florida 32080 and the registered office of this corporation is hereby designated to be 6325 Salado Road, St. Augustine, Florida 32080. The principal place of business and registered office may be changed in accordance with the By-Laws of the corporation or by appropriate action of the Board of Directors. The initial Registered Agent of this corporation whose business office is the same as the registered office is hereby designated to be Paul Gronquist, 6325 Salado Road, St. Augustine Florida 32080.

ARTICLE III

Nature of Business

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

By-Laws

The corporation may in its by-laws make any other provisions or requirements for the management or conduct of the business of the corporation, provided the same is not inconsistent with the provision of this certificate, or contrary to the laws of this State or of the United States.

ARTICLE V

Capital Stock
