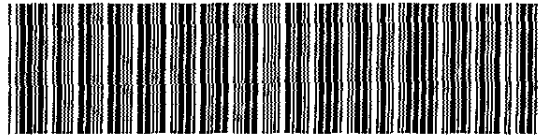

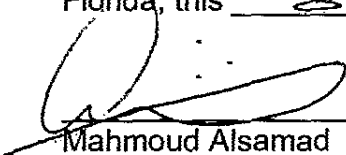

These Articles of Incorporation shall be effective immediately upon execution.

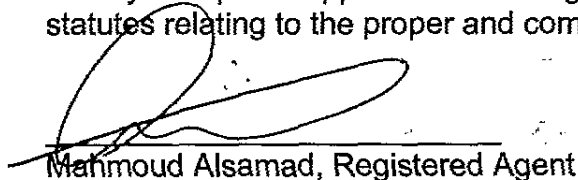
